4. Assessment Report Update

Rhonda Bateman confirmed that the final version of the Amended Assessment Report was submitted to the Ministry of the Environment (MOE). Subhash Verma reported he had received confirmation from the MOE that the Assessment Report had been received and thanked the Drinking Water Source Protection Planning staff for their hard work in meeting the delivery timelines. The next step is approval of the Assessment Report from the Minister of the Environment.

5. MOE Update

Wesley Wright reported that in answer to questions posed at the last meeting about the threat status of geothermal units, he had sent a response to Rhonda via email.

Closed loop heat transfer fluids (htf) are a low drinking water threat at most in residential areas but can become significant in large commercial units due to the high volumes of htf used.

Catherine Taddo offered more information regarding open and closed loop systems to the committee.

6. Source Protection Planning

The Steelton update by Andrew Hallett was deferred until the next meeting.

Rhonda demonstrated the Policy Entry database created by Thames River to the SPC members.

Rhonda will create one user id that all SPC members can use. She proposed undertaking the draft policy review online during the meeting so that the members could see how the database functions.
