- Climate Change Vulnerability Assessment Tool information and demo
 - o After the last meeting I had distributed the guidelines for this tool for information.
 - Demo of three scenarios, with the first scenario with the trend analysis in the CC Exposure sheet setting all trends to increasing of temperature and precipitation; a high uncertainty of the data that resulted in a summary that was HIGH concern for Climate Change.
 - The second scenario with a trend analysis in the CC Exposure sheet setting all trends to decreasing with a low uncertainty of the data that resulted in a summary that was LOW concern for Climate Change.
 - The third scenario with a trend analysis in the CC Exposure sheet setting all trends to no changing with a high uncertainty of the data that resulted in a summary that was HIGH concern for Climate Change.
 - Exact data will have to be peer reviewed to ensure that data in the tool is accurate.
 - This will be a good benchmark going into the future of Climate Change.
